## **4-YEAR COMPRESSOR PLAN (Optional)**

Frizair Corporation, hereinafter referred to as “Frizair”, warrants to the original purchaser of the Frizair room airconditioner under the Optional Frizair’s 4-year Compressor Plan that for a period of 48 months commencing immediately at the end of 365 days from the original date of invoice. Frizair will repair or replace the COMPRESSOR ONLY which proves upon inspection and in the opinion of Frizair or any of its authorized representatives to be defective due to faulty material or workmanship only. This warranty is subject to the following Terms and Conditions.

- . Frizair Corporation hereby contracts with the purchase/owner of the Frizair Airconditioner, details of which are more particularly set out hereunder, that, subject to the conditions set out hereinafter, for a period of 48 months commencing immediately after the expiry of the one year warranty period from the date of Invoice. Frizair will, in consideration of Service Charges received repair the airconditioner’s compressor or replace the same with another in working condition, as and when required. If the compressor in spite of normal and proper use, is proved to be defective or inoperative. The Optional Frizair’s 4 year Compressor Plan covers compressor alone. It does not cover any other part.
- . This Frizair’s 4-year compressor plan will automatically terminate on the expiry of the Frizair’s 4-year compressor plan period of 48 months, even if the Airconditioner may not be in use for any time during this period for any reason whatsoever including any technical breakdowns, and the time taken for such repairs/replacements of parts and transit, whether under this Warranty or otherwise, shall not be excluded from the warranty period.
- . This Frizair’s 4-year compressor plan will come into effect only after receipt of the optional warranty charges of Rs.1500 by Frizair. In case payment is made by Cheque Demand Draft or Banker’s Cheque, the Frizair’s 4-year compressor plan charges (either whole or partial) will be accepted by Frizair under any circumstances.
- . This Frizair’s 4-year compressor plan is subject to Acceptance by Frizair in writing and will come into effect only after the duplicate copy of this document is duly filled in, signed and returned to purchaser by Frizair. No cancellation of Frizair’s 4-year compressor plan or refund of Frizair’s 4-year compressor charges (either whole or partial) will be accepted by Frizair under any circumstances.
- . This warranty does not apply to defects arising. In Frizair’s opinion. If the unit is subjected to abuse, misuse improper installation, improper voltage or electrical connection, neglect, alteration, accident, damage caused by transportation, flood, fire, acts of God, unauthorised repairs or replacement of original parts.
- . The replacement of the Compressor will not carry any independent Frizair’s 4-year compressor plan.

- . This Frizair's 4-year compressor plan is void if the unit is installed repaired or serviced by any party other than Frizair's authorized representative and if written notification of any defect is not given to Frizair within a period of one week.
- . Frizair's decision to repair/replace defective parts shall be final and conclusive.
- . This warranty applies only to units installed within the municipal limits of towns and places where Frizair's authorized service representative is available.
- . This warranty is confined to repairs or replacement of defective parts and does not cover any implied or consequential or resulting liability, damage or loss arising from such defects. Further, in no case shall the warranty extend to payment of any monetary consideration or replacement or return of the airconditioner.
- . This warranty does not cover the following:
  - Refrigerant Gas charged in order to repair/replace the compressor under this warranty.
  - Transportation charges incurred in order to repair/replace the compressor under this warranty.
  - Charges for replacing any other components which require to be replaced as a consequence of compressor defect or failure or for the purpose of compressor repair/replacement.
  - Defects arising due to operation of the unit in abnormally corrosive conditions.
  - Charges for Servicing / Cleaning of airconditioner carried out along with compressors repair/replacement.
- . While FRIZAIR will make every effort to carry out repairs/replacements of parts under this Warranty as soon as possible, it is expressly made clear the FRIZAIR shall not be liable to do so within any specified period of time.
- . This warranty holds good only so long as there is correct use and maintenance of the Airconditioner.
- . If the original serial numbers are removed obliterated or altered from the compressor or the cabinet this warranty will cease to be valid.
- . The room airconditioner is designed to operate between 207 and 253 volts. Any defect failure due to operation of the machine beyond these limits will not be covered by this Frizair's 4-year compressor plan.
- . Notwithstanding anything contained above, Frizair will not be liable or responsible in any other manner, implied or otherwise except for those which are clearly admitted or expressly stated herein.
- . It is entirely left to Frizair's discretion to effect repairs/replacements of parts at the site of installation or at the Service Stations of its Branches or of its Authorised "Representative/Dealers.
